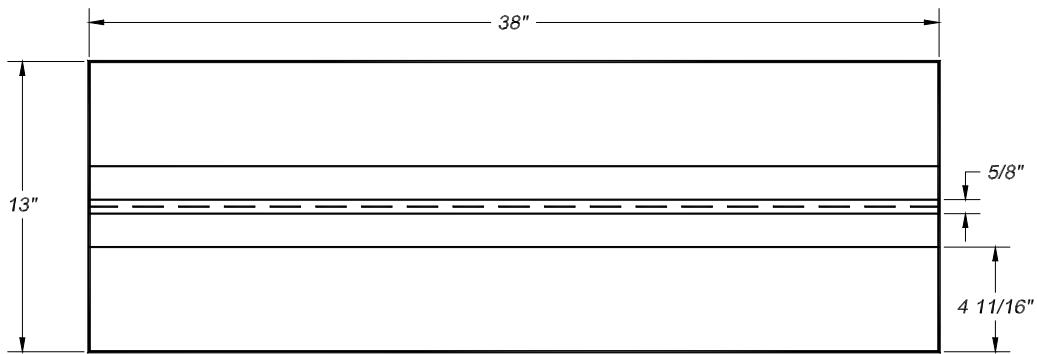

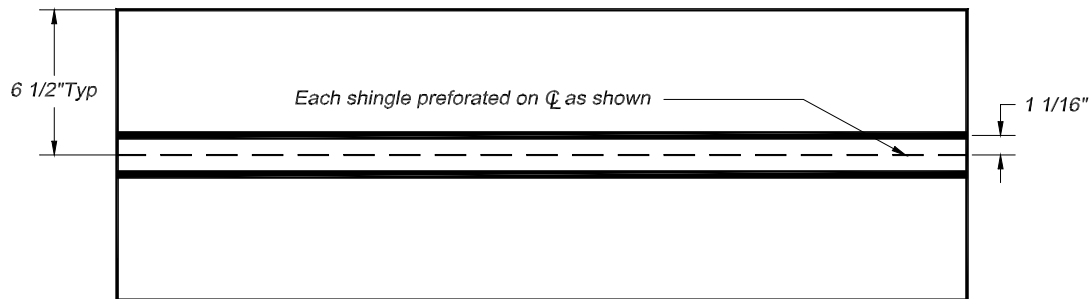

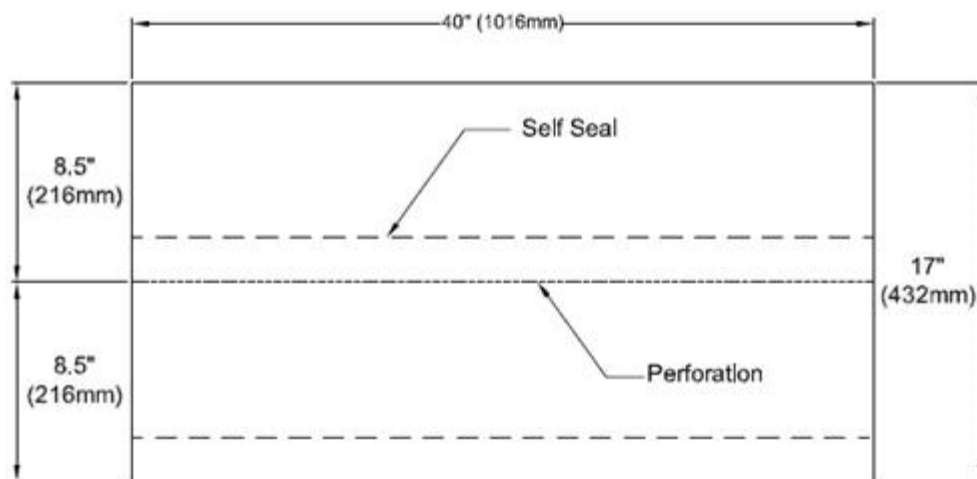


BACK VIEW
